#### **EUREKA TOWN BOARD MEETING**

#### FEBRUARY 12, 2018

Chair Lu Barfknecht called the meeting to order at 7:00 p.m. and the Pledge of Allegiance was given. Town Board Supervisors present were Lu Barfknecht, Carrie Jennings, Butch Hansen, Donovan Palmquist, and Dan Rogers. Planning Commission members Nancy Sauber and Ralph Fredlund, Township Attorney Chad Lemmons, Clerk Mira Broyles and Treasurer Marcia Wilson were also present. See attached list for others in attendance.

#### APPROVAL OF THE AGENDA

Changes to the agenda were made as follows:

Land Use Permits was moved to the beginning of the agenda.

Motion was made by Chair Barfknecht, seconded by Supervisor Hansen, to approve the agenda as amended. Motion carried 5-0.

#### **Land Use Permits**

Patrick and Jean Mahowald, 6429 265th Street - Lot Split Approval Application

It was noted that the Planning Commission had recommended approval of the application.

Motion was made by Supervisor Jennings, seconded by Supervisor Hansen, to approve a lot split for Patrick ad Jean Mahowald, 6429 265<sup>th</sup> Street as follows: Parcel A consisting of 3.54 acres, PIN 13-02600-26-012, Parcel B, consisting of 2.91 acres to be split from Parcel A and then combined from with adjacent 5.0 acre parcel, PIN 13-02600-27-010, creating Parcel C. Motion carried 5-0.

#### TREASURER'S REPORT

Motion was made by Supervisor Rogers, seconded by Supervisor Palmquist, to accept the Treasurer's Report dated February 12, 2018 as amended. Motion carried 5-0.

The claims and receipt lists and outstanding invoices were reviewed.

It was noted that the next Attorney's bill will reflect an adjustment of 1.5 hours.

Motion made by Supervisor Jennings, seconded by Supervisor Palmquist to approve the claims and receipt lists as adjusted. Roll call vote was taken. Motion carried 5-0.

The proposed budget for 2019 was reviewed.

It was noted that an escrow in the amount of \$5,000 is being held for Adam Jakes in conjunction with a building permit and the demolition of an existing structure on his property.

Motion by Supervisor Hansen, seconded by Supervisor Rogers to direct the Clerk to send a letter to Adam Jakes regarding the status of his building permit. Motion carried 5-0.

Motion was made by Chair Barfknecht, seconded by Supervisor Rogers, to approve the balance of the Treasurer's report. Motion carried 5-0.

#### **Public Comment**

Jody Arman Jones bought to the attention of the Board that Ray Swedeen, a long time Eureka resident had passed away. It was noted that he had started the "history wall" in the Town Hall.

Motion was made by Supervisor Hansen, seconded by Chair Barfknecht, to direct Jody Arman Jones to include a notice in the upcoming newsletter. Motion carried 5-0.

The Clerk was directed to update the history wall.

#### **Contractor Time**

Jason Otte, Otte Excavating, provided an update on ongoing road maintenance.

Deputy Sheriff Schmidt was present and discussed recent burglaries that have occurred by someone on a snowmobile. He also noted that snowmobiles advertised for sale on the side of roads had been stolen and cautioned residents to somehow secure them.

#### **Building Inspector Update**

Supervisor Hansen noted that Darrel Gilmer had conducted an inspection for an emergency furnace replacement.

Motion was made by Supervisor Hansen, seconded by Chair Barfknecht, to approve the minutes of the January 8, 2018 Town Board meeting as amended. Motion carried 4-0. Supervisor Rogers abstained.

#### **Planning Commission Update**

Planning Commissioner Bill Funk provided a summary of the February 5, 2018 Planning Commission meeting. Discussion was held regarding plantings in rights of way and ditches. The Planning Commission was directed to draft new ordinance language.

Jody Arman Jones reviewed the draft of the first quarter newsletter.

#### <u>Annual Review – Brosseth and Storlie Gravel Pits</u>

Pat Mason, Ames Construction, was present for the annual review of the Brosseth and Storlie gravel pits. Noise issues were discussed.

There were no public comments made regarding the pits.

Motion was made by Supervisor Jennings, seconded by Supervisor Hansen to provide the well readings of the Brosseth pit to Mark Zabel with Dakota County. Motion carried 5-0

Motion was made by Supervisor Hansen, seconded by Supervisor Jennings to approve the gravel permit review of the Brosseth mine. Motion carried 5-0

There was no public comment regarding the Storlie mine.

Motion made by Chair Barfknecht, seconded by Supervisor Hansen, to approve the gravel permit review of the Storlie gravel pit. Motion carried 5-0.

#### Annual Review - Friedges Landscaping Gravel Pit

Justin Friedges was present for the annual review of the Friedges Landscaping Gravel Pit.

There was no public comment regarding the gravel pit.

Motion was made by Chair Barfknecht, seconded by Supervisor Palmquist to approve the review of the Friedges Landscaping Gravel Pit. Motion carried 4-0. Supervisor Hansen abstained.

Motion was made by Chair Barfknecht, seconded by Supervisor Palmquist, to approve the Building Official Services Agreement with MNSPECT, LLC as amended. Motion carried 4-1. Supervisors Hansen opposed.

#### Airlake Airport

Supervisor Hansen stated he would get in touch with Gary Schmidt regarding a meeting to discuss further action pertaining to the orderly annexation of the Airlake Airport into Lakeville. Future negotiations were discussed. It was noted that the Board will be notified of the meeting and negotiation points.

#### **Other Business**

#### **Resolution Appointing Election Judges**

Motion was made by Supervisor Jennings, seconded by Supervisor Rogers, to adopt Resolution 2018-02, appointing Election Judges for the March 13, 2018 Township election. Motion carried 5-0.

#### **Annual Meeting Preparation**

Discussion was held regarding the presentation for the March 13, 2018 annual meeting.

#### **Application Forms**

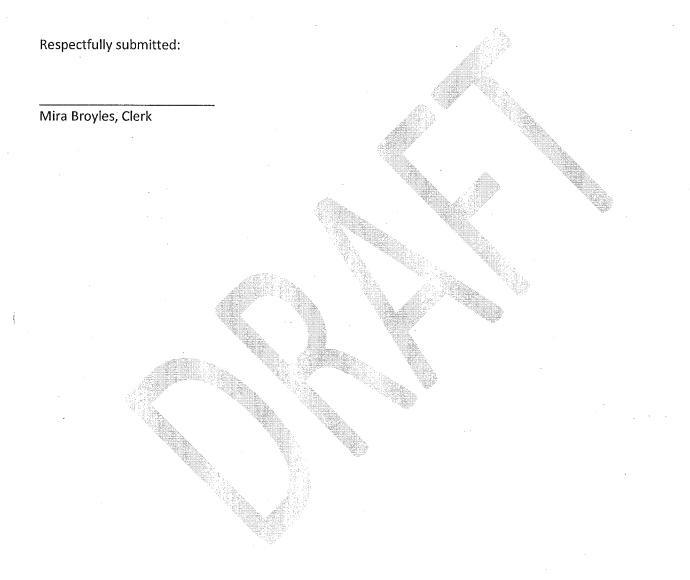
Revised application forms were reviewed and approved for completion.
