SPECIAL REORGANIZATION MEETING OF APRIL 14, 2020

Due to the Peacetime Emergency declared by Governor Walz under Minnesota Statutes Chapter 12, the Health Pandemic that is COVID-19 as labeled by the Center for Disease Control, and the Stay-at-Home Order as declared by Minnesota Executive Order 20-20, the following meeting shall be conducted entirely through teleconferencing or other electronic means.

Call to Order

The Eureka Township Special Reorganization meeting was called to order, via Zoom Meetings, at 7:00 p.m. by Chair Donovan Palmquist and the Pledge of Allegiance was given.

Chair Palmquist opened the floor for nominations for the 2020-2021 Town Board Chair and Vice Chair and called for a ballot vote. Each Supervisor submitted their nominations to the Clerk via email. The Clerk read the votes for Chair: 4 votes for Donovan Palmquist and 1 vote for Lu Barfknecht. The Clerk read the votes for Vice Chair: 3 votes for Tim Murphy and 2 votes for Lu Barfknecht. Donovan Palmquist was appointed as Chair and Tim Murphy was appointed as Vice Chair.

Donovan Palmquist accepted the appointment and proceeded as Chair for the meeting.

Approval of the Agenda

Adopt Resolution 2020-03 setting regular Town Board meeting dates and time

Supervisor Fredlund presented a proposal to the Board to adopt two regular meetings per month. Discussion concluded a consensus that having two meetings would result in shorter meetings, being more responsive to citizens, faster payment of bills and elimination of late fees, no overtime fees to the Attorney, agendas can be modified to accommodate unforeseen items thus eliminating the need and cost for special meetings. Chair Palmquist suggested that the meeting on the second Monday each month be the Primary meeting, and the Secondary meeting on the fourth Monday each month be used for critical issues and disbursements, with the option to cancel the meeting if there is no need.

- 1. Policy for recording meetings
 Recordings of regular and special meetings are to be used for transcription purposes and
 are to be destroyed after approval of the minutes unless specifically directed to preserve
 the recording. Recordings for public hearings are to be preserved. Recordings of
 meetings are available to the public until approval of the minutes for that meeting.
- 2. Authorization for payment of potential training opportunities Payment for training opportunities must have prior approval by the Town Board.
- 3. Opinion statement

In the event a Town Board member is asked for an opinion on a specific matter, he/she must make it perfectly clear that any opinion given is only his/her opinion and not that of the Board as a whole. Even though a Board member's opinion may be given, the issue would need to go before the Town Board for discussion and vote. An individual may not act upon one Town Board member's opinion. Discussion or communication on any matter can be discussed only between two Town Board members, as discussion or communication between three or more members of the Board constitutes a quorum and a violation of the open meeting law. The Building Official is the contact person if determination is needed regarding a building permit.

6. Potential conflict of interest policy
Due to potential conflicts of interest regarding work awarded by the Township, no Town
Board supervisor and/or Planning Commission member may be awarded those contracts.
