Township roads report

Road Grading

To keep dust at a minimum and ensure that the roads are compacted properly, it is preferable to grade the roads while damp. This spring's dry weather has made it a challenge to keep the roads properly graded. Thank you for your patience.

Farming in Right-of-Way

Reminder: in order to protect the drainage, access, and quality of our roads, the Township does not allow farming in the right-of-way. Crops that are planted in the right-of-way will be mowed. Are Township Building Rights Changing Soon?

It has recently come to the attention of the Town Board that there are rumors that allowable housing rights in Eureka Township are going to increase based on changing the current agricultural zoning from one house per quarter-quarter section (forty acres) to one house in ten or even five acres across the Township, or that there may be a change in minimum lot size from two acres to ten acres.

This is not true, nor are such changes entirely in the hands of the Town Board or Township voters. Why?

- Eureka's land use is subject to oversight by the Metropolitan Council.
 Any Comprehensive Plans or Comprehensive Plan amendments
 ultimately must be approved by the Council. To be approved, the Plans
 must be consistent with the Council's systems statements for the
 region.
- To change to one house per ten acres would require a change in zoning.
- The Metropolitan Council has advised that under their systems statements they see Eureka as agricultural until 2040. Agricultural zoning means one house in forty acres density.
- Metropolitan Council representatives have informed members of the Board that there is no policymaker support on the Council to rezone all or even part of the Township to one house in ten.

Keep an eye out for noxious weeds!

Now that our growing season has kicked into high gear, this of course means noxious weeds are spreading, too. Please check your area and be aggressive in eradicating noxious weeds on your property. If you see noxious weeds growing along township roads or in open areas, please contact road supervisor Donovan Palmquist at (612) 250-6208. Include the specific location of the sighting. Area farmers — and your neighbors — will be grateful!

Warning: noxious weeds such as poison hemlock and wild parsnip are dangerous to handle. Use gloves, long sleeves, long pants, and closed-toe boots when working on an infestation.

Wild parsnip is found along roadsides and in disturbed soil. It is an aggressive, monocarpic perennial plant that germinates from seed, spends the first year or more as a rosette, eventually bolts into a mature plant in the second year or later, flowers, sets seed, and dies. Grows 4- 6 feet tall. Leaves alternate along the stem, are pinnately compound, and consist of egg-shaped leaflets having saw-toothed edges that are arranged in pairs along the stalk; becoming progressively smaller near the top of the stem. Bolted stems are erect, branched, hollow, slightly grooved, and terminate in flat-topped, compound flower umbels. Umbels are generally 2- 6 inches wide and contain many small, 5- petaled yellow flowers that bloom from June through late August.

Please note that a similar-looking plant, golden alexander, is native and not invasive. Golden alexander leaves are smooth and finely serrated, it is smaller (up to three feet), and it blooms earlier in the season.
