The Clerk may issue the Certificate of Election following the Contest period.

The Oath of Office must be taken within 7 days of issuance of the Certificate of Election. (Before March 29, 2010)

Clerk Nanett Sandstrom presented the Town Board members with a copy of the election results tape, Summary Statement Worksheet and the Election Board Summary Statement/ Canvass Board Certification.

The Town Board reviewed the election results and certified the Official Election Results for Supervisor Seat #5
