

EUREKA TOWNSHIP MEETING OCTOBER 9, 1989

MEETING CALLED TO ORDER AT 7:30 P.M. BY VICE CHAIRPERSON SCHINDLEDECKER PRESENT WERE SUPERVISORS CURRY AND KADLEC, CLERK LEINE AND TREASURE SCHULZ.

CURRY MOVED TO ACCEPT SEPTEMBER MINUTES AS READ BY CLERK LEINE. KADLEC SECONDED MOTION AND MOTION CARRIED.

KADLEC MOVED TO EXCEPT SEPTEMBER TREASURES REPORTS AS READ, SECONDED BY CURRY AND CARRIED.

CLERK LEINE PRESENTED THE BOARD WITH BILLS TOTALLING \$17,403.04. CURRY MOVED TO PAY BILLS, SECONDED BY KALDEC AND CARRIED.

THERE WAS NO REPORT FROM THE PLANNING COMMISSION.

MIKE MAHONEY, 8150 W 250TH ST. REQUESTED A PERMIT FOR A 32 X 180 POLE BUILDING ON THE 20 ACRES HE OWNS. A PERMIT FEE OF \$57.60 WAS ASSESSED. KADLEC MOVED TO GRANT PERMIT. SECONDED BY CURRY AND CARRIED.

TOM BEIS, 8125 W 240TH ST, REQUESTED A PERMIT FOR A POOL. A FEE OF \$25 00 WAS ASSESSED. CURRY MOVED TO GRANT PERMIT, SECONDED BY KADLEC AND CARRIED.

RONALD ERICKSON, 24425 HIGHVIEW, REQUEST A PEMIT FOR A POLE BUILDING TO BE ERECTED AT 10391 250TH ST. BOARD INFORMED ERICKSON THAT WITHOUT PLANS TO BUILD A HOUSE A POLE BUILDING COULD NOT BE ERECTED. ERICKSON SAID THAT HE WOULD COMPLY WITH TOWNSHIP POLICY AND SUBMIT HOUSE PLANS ALONG WITH POLE BUILDING PLANS. VALUE OF HOUSE AND POLE BUILDING WAS ASSESSED AT \$779.25. CURRY MOVED TO GRANT PERMIT FOR BOTH STRUCTURES CONTENGENT UPON SHOWING CLERK LEINE A SET OF SIGNED PRINTS BY THE BUILDING INSPECTOR. THIS MOTION WAS SECONDED BY KADLEC AND CARRIED.

STEPHEN ZENDER, 4558 JOHNNY CAKE RIDGE, EAGAN (H&Z TREE FARM) CAME BEFORE BOARD TO RENEW C.U.P. FOR THEIR CHRISTMAS TREE FARM ON 235TH ST 3/4 MILES EAST OF DODD. CURRY MOVED TO RENEW PERMIT, SECONDED BY KADLEC AND CARRIED. C.U.P. RENEWAL FEE WAS SET AT \$10.00.

GREGG GUDBJARTTSON AND GARY GREEN WERE APPOINTED TO THE PLANNING COMMISSION BY THE TOWN BOARD.

DR. PETTIS INFORMED BOARD MEMBERS HE WISHED TO REMAIN ON PLANNING COMMISSION.

AIRLAKE AIAPORT HAS SENT THE TOWNSHIP A COPY OF THEIR SEVEN YEAR PLAN FOP AIRLAKE STARTING IN 1990. IF ANYONE WISHES TO READ THIS REPORT THEY SHOULD CONTACT VICE CHAIR SCHINDLEDECKER.
