Eureka Township Board Meeting November 10,1986

The meeting was called to order at 7:30 P.M. by chairman Schindeldecker. Present were supervisors Kadlec, Curry, Larson and Lee. Also present were clerk Leine and treasurer Shaff.

Minutes of the previous meeting were read by Leine. Larson made a motion to accept the minutes as read. Motion seconded by Curry and carried.

Treasurer's report was given by Shaff. Curry made a motion to accept the report. Motion seconded by Larson and carried.

Leine presented bills totaling \$9,338.90. After a brief discussion Lee made a motion to pay all bills presented. Motion seconded by Curry and carried with no dissenting votes.

There was discussion of asphalt patching and seal coating Eureka Estates and Riceland Acres. It was agreed to get cost figures and present the matter at the annual township meeting. Proposal would be to assess cost against land owner adjacent to streets on which work is to be done.

Roapraj Oudhray, 315 Pine St., Farmington again appeared before the board regarding building on a parcel of land as discussed in the November meeting. A perk test had been done and it appeared the land may not be buildable due perkability. There was discussion of alternate septic systems. Party is to look into costs of alternate systems, and will again appear if cost practical.

Tom Prose 13221 Parkwood Dr., Burnsville requested a permit for a two level, 28 by 38 foot house with attached 24 by 32 foot garage at 8094 257th street. Plans and plot plans, etc. submitted. Motion by Curry to grant the permit. Motion seconded by Kadlec and carried with no dissenting votes.

Greg Gudbjartsson, 24345 Highview, requested permits to build a two level house addition, a 12 by 24 foot screen porch and a 28 by 38 foot pole building. Plans, plot plans, etc., submitted. Larson made a motion to grant the permit. Motion seconded by Lee and carried unanimously.

David Weil, 4615 Parkridge Dr., Eagan, requested a permit to build a 40 by 46 foot hanger on plot El at Airlake Airport. Lease, plans, etc., submitted. Larson made a motion to grant the permit. Motion seconded by Curry and carried with no dissenting votes.

Schindeldecker read a letter initiated by the board attorney to Mr. Hraby regarding violation of ordinance 20. Letter was dated November 5, 1986.

Ray hall, 8236 225th street, requested a permit to build a 48 by 140 foot pole building. Plans, etc. submitted. Motion by Larson to grant the permit. Motion seconded by Kadlec and carried unanimously.

Schindeldecker to notify Mr. Finney of M.A.C. of townships representatives, Curry and Lee, to the Airport Advisory Commission.

Eureka Estates, stage two is becoming active. Mr. R. Mac Donald is the developer. Schindeldecker expressed concern, for the safety aspect of citizens, that there is only one access to the development. Schindeldecker is working with John Forrest, Dakota County, to require a second access.

Curry, as a member of the Community Development District 1, explained the Community Development Grant Program. It was suggested the upgrade/repair of the bridge on 220th street west of Farmington be a combined. (City of Farmington and Eureka Township) grant request. No final decision was made.

Motion by Kadlec to pay \$120.00 for three election judges pay. Mot ion seconded by Lee and carried.

Board attorney, Wm. Macklin, offered some advice to the township board regarding individual board member responsibility and authority while acting on behalf of the township governing body. A synopsis of that information is here attached.
