

Eureka Township  
Board Meeting  
November 9, 1981

The November Meeting of the town board was held at the town hall.

Smith, Johnson, and Kadlec present.

The minutes of the last meeting were corrected to read that Osterman's request for a horse barn and riding arena was referred to the planning commission at a public hearing. Kadlec's motion, seconded by Johnson, passed to accept.

Treasurer report accepted as read.

Bills were presented. Johnson made a motion to pay all bills and to inform Mr. Danielson that we may not put up any more snow fence. Seconded by Kadlec.

Mrs. Eugene Karal requested a permit for an addition to their home. Johnson's motion seconded by Kadlec, passed.

Rodney Schmidt requested a permit for a home on a 4 acre lot south of Chub Lake. Johnson's motion to allow same after MC Clusky has approved the plans. Seconded by Kadlec and passed.

Mr. Scheide representing Osterman's inquired about the construction for the horse barn and arena on their 8 acre lot. He was told to appear at the public hearing December 1 at the planning commission meeting.

Mark Vesta then came up to ask for a house permit in Eureka Estates. He had not been to the planning commission meeting as he just received his financing that day, but he had been to the building inspector to have his plans approved. Because of the late start he asked to be given a permit. Johnson made a motion to grant, seconded by Smith with the condition the planning commission check the plans. Vote Johnson yes, Smith yes, Kadlec no.

Robert Laddusaw and Richard Lee applied for the vacancy on the board. Johnson tabled this matter till next meeting, seconded by Kadlec, carried.

Ordinance 22, Right to Farm, was read by Smith.. Johnson's motion to adopt the ordinance, seconded by Kadlec, passed.

The clerk was given permission to order L. P. gas.

Jim Topp came to the meeting with the articles of Incorporation for the Castle Rock Community Club. Johnson made a motion to give the Castle Rock School to the Club and the township to pay for the transfer of title. Kadlec seconded, all in favor.

Kadlec made a motion to give the funds in the Castle Rock fund to the club. Seconded by Johnson, all in favor.

John Forrest, County planner came with his recommendations of how to rezone part of our township. Johnson made a motion to authorize Mr. Forrest to send necessary papers to the Metropolitan Council and draw up necessary papers and forms to have published in the paper. Copy of papers filed in cabinet.

The resolution for the Metropolitan Agriculture Preserves Act was adopted on a motion by Johnson seconded by Kadlec.

Mr. Forrest advised the board about the wetland protected waters act. The D.N.R. sent a map and all the people living along the protected waterways have been notified.

A vote of thanks was ordered sent to County Commissioners for Mr. Forrest and the planners efforts in our behalf.
