Eureka Township Board Meeting February 8, 1982

The meeting opened at 7:35. All present.

Clerk read the minutes of the last meting. Approved as read.

Treasurer report was given and accepted as read.

Bills were presented. Johnson made a motion to pay Henry Larson's gravel bill from revenue sharing, seconded by Kadlec and passed. Sauber made a motion to pay the rest of the bills from the regular fund. Seconded by Kadlec, passed.

The filing of records has not been started, but the clerk reported he has them all taken care of, but Cheryl will help by making copies, etc.

There was no activity from the planning commission at the February meeting.

A motion was made by Johnson to put an ad in the paper to ask for candidates for the planning board, seconded by Sauber.

Smith informed the board that he has talked to Dewey Reinholt about insurance on the Castle Rock School and other types of insurance. Sauber made a motion to have the board purchase workman's comp insurance. Seconded by Johnson. Carried.

Johnson made a motion to carry the liability on the Castle Rock School for one more year and to inform the non profit organization of this decision; that it will be for only one more year, so it does not become a burden for the township. Seconded by Kadlec and approved.

Smith read a notice from the MET Council about rezoning of part of the township.

Johnson made a motion to send a letter of support to Representative Tom Rees in support of a bill to put a moratorium on sludge and ash sites in the state. Copies to be sent to Swiggum, Sieben and Rodigruy. Sauber seconded and it was approved.

Rother complained that some people were pushing driveway snow piles into the right of way which is against the law, making snow removal difficult. Johnson made a motion to have Rother notify the clerk about this and he will call these people and inform them of the violation. Seconded by Kadlec and passed.

Smith talked about the desire of people to rezone their land. He suggested that ordinance 20 be changed. Part 6.41 B. Johnson suggested that Smith talked to our lawyer and Wally Gustafson of the township officer's association to find out what the township can

do about petitions and ordinance changes. After discussion he made it a motion, seconded by Kadlec, approved.

Johnson made a motion to accept the petition to rezone the township and to table until after the March election. Sauber seconded. Vote Sauber yes, Johnson yes, Smith no, Kadlec no. Motion died.

Kadlec made a motion to put a referendum out to put the petition to rezone to 1 on 40 on the ballot at the annual election and let the people vote on the matter. Johnson will go along with this if an ad is put in the paper to be worded as agreed by all. Sauber seconded amended to say board will abide by the results of the vote, all in favor. Kadlec's motion to have the ballot say: "Shall Eureka Township amend it zoning to be rezoned to one dwelling per 40 Acre (1/4 of 1/4 section)" seconded by Sauber all in favor.

Johnson read an agreement from Lakeville regarding building inspector. The agreement is about the same as provided now. Johnson made a motion to forward the agreement of the joint venture with the Lakeville City. Motion seconded by Kadlec and approved.

Johnson made a motion to approve a late bill. Sauber snow fence \$60.00.

Budget was discussed. Johnson made a motion of a limit levy \$77,339.00 seconded by Sauber and approved.

The clerk read a list of names of people filed for office.
