Eureka Township Board meeting March 10,1986

The meeting was called to order at 7:30pm .by chairman Kadlec. Present were supervisors Schindledecker, Lee, Larson and Curry, as were clerk Leine and treasurer Shaff.

Leine read the minutes of the previous meeting. There was a minor correction on wording regarding total fire calls responded to by Lakeville and Farmington fire depts. Curry made a motion to accept the minutes as amended. Motion seconded by Lee and carried.

Treasurer's report given by Shaff. There was discussion of monies received from the state and taxes. Schindledecker made a motion to change the township physical year o be January 1st to December 31st effective immediately. This making the physical year or 1986 as March 1 to December 31. Motion seconded by Lee. Motion carried with no dissenting votes. Lee made a motion to accept the treasurer's report as given. Motion seconded by Schindledecker and carried unanimously.

Clerk Leine presented bills totaling \$3835.30. After discussion Curry made a motion to pay all bills presented. Motion seconded by Schindledecker and carried unanimous.

Wm. Ratzlaff, 9020 235th Street W. requested a permit for a 32 by 48 foot garage. Garage to be pole type construction built by Fredrickson Construction. Estimated cost \$7300.00. Plot plan presented. Larson made a motion to grant the permit. Motion seconded by Curry. Motion passed with no dissenting votes.

Schindledecker reported that John Forest's office at Dakota County Govt. Center has township ordinance 20 on it's computer and had suggested it would put balance of the Ordinances on as time permitted. To put this on the computer will be at no cost to the Township. Board advised Schindledecker to follow up until job is completed. After completion ordinances will be screened by board.

Lee made a report regarding his discussion with board attorney regarding request for Splat Ball permit He reported the attorney felt it fell under recreational category of functions as far as permits was required. There were expressions by members of the board of concern for township liability. It was agreed to hold a public hearing on the request or a permit on April 7th, 1986 if the party requested such a hearing.

There was discussion of townships responsibility to provide fire protection for Citizenry. It was stated that the citizens voted to have township responsibility originally and would have to vote on removal if it is to be discontinued. Curry suggested a committee be set up to investigate the possibilities of seeking reimbursement from homeowner for fire calls. This reimbursement may be in conjunction with monies they receive torn fire insurance payments. Schindledecker volunteered to serve. Curry made a motion committee contact cities of Farmington and Lakeville to see if there is a possibility they would bill citizens for payment on fire or rescue calls and deduct amount received from annual billing. Motion seconded by Lee. Motion carried with no dissenting votes,

Schindledecker brought a copy of a contract A.L.F. wanted the township to sign which would guaranteed payment by the township for ambulance services. Also contract called for large assumption of legal liabilities by the township. The board felt some type guarantees may be necessary to insure ambulance service, but felt the contract as submitted was not acceptable. Board to study and discuss the matter further at a future meeting.

Lee reported going to a Cannon Watershed Management meeting on February 27,1986. Group is attempting to apply for a S.W.C.D. grant to pay for some of the costs. Lee reported our township would have to pay \$1000.00 in June of this year as it now stands. The next meeting of the group is April 1i7,1986.

The township reorganization meeting was set for March 17,1986 at 7:30 P.M..

John Curry reported he had had a complaint regarding Mike Malone property on 240th street. There was an abundance of trash and junk accumulation. Board directed Curry to follow up with Malone to get property cleaned up.

John Curry requested a permit to build a pole building, 40 by 40 feet, on his property on 235th street Plot plans submitted Lee made a motion to grant the permit Motion seconded by Larson and carried with no dissenting votes

At 10:15 PM Curry made a motion, to adjourn. Motion seconded by Lee and carried.
