

EUREKA TOWN BOARD MEETING MARCH 10 1997

The Meeting was called to order by Chairperson Schindledecker. Present were Supervisors Johnson, Kadlec, Smith and Topp, Clerk Leine and Treasurer Schulz.

Supervisor Topp moved to accept the February minutes with the following correction, Page 1, Paragraph 5; remove "Fredrickson" in line 4. This motion was seconded by Supervisor Johnson and carried.

Supervisor Kadlec moved to accept the Treasurers report as read, seconded by Supervisor Topp and carried.

Supervisor Smith moved to pay the bills that Clerk Leine presented, seconded by Supervisor Topp and carried.

Charlie Laine, 9020 - 235th St. W., requested a permit for a 32 x 80 foot addition to an existing pole frame building. Supervisor Topp moved to grant permit contingent upon showing Clerk Leine a set of signed prints showing a 40 pound snow load roof. Supervisor Smith seconded this motion, and the board passed motion unanimously.

Mike Todd, 6385 - 265th St. W., requested a permit for a 1848 Square Foot rambler house to replace house destroyed by fire. Mr. Todd had all needed requirements to draw permit. This house is a replacement house and therefore is assessed only 1/2 the normal permit fee. Supervisor Kadlec moved to grant permit, seconded by Supervisor Johnson and carried.

Cheryl Monson, 10391 - 247th St. W., requested a permit for a 78 x 108 foot pole frame building. This building will be used as a riding arena. Supervisor Topp moved to grant permit contingent upon signed plans showing snow load of building and upon the approval of the Shore Land Zoning District's approval of this project. Supervisor Smith seconded this motion and carried.

Mrs. Mattson, 9035 - 267th St. W., requested a land split in Section 29, Township 113, Range 20, Dakota Co. (See Attached Surveyor's Certificate for Legal Description) Supervisor Topp moved to grant split, seconded by Supervisor Johnson and carried.

Paul Ryan, 9320 - 267th St. W., represented by Valley Pools, requested a permit to install a 18 x 37 pool. Lot plans and lay out of pool were shown. Supervisor Smith moved to grant permit with the addition on a 4.5 foot high non - climbable fence with a self - closing gate, seconded by Supervisor Johnson and carried.

C.J.Juvland, asked the board how many building permits were available on the 192 acres he owns in Section 34. The board informed Mr. Juvland there were 5 permits available at present. The board also informed Mr. Juvland that the land must be split and recorded while he was the owner of all the property.

Calvin Pflaum, 5780 - 225th St. W., requested a permit for a 44 x 80 pole frame building. Lot plans and signed building prints were on hand showing location and size of building. Supervisor Topp moved to grant permit, seconded by Supervisor Kadlec and carried.

The board instructed Miller Construction to remove all Minimum Maintenance signs from the township roads.

Supervisor Topp moved to pay per per-diem for up to four persons attending the Dakota Co. Soil and Water Conservation feed lot meeting, seconded by Supervisor Johnson and carried.

Supervisor Smith moved to adjourn meeting, seconded by Supervisor Topp, and carried.
