Annual Town Meeting March 14, 1972

The annual Town meeting, held in the Town of Eureka in the County of Dakota and State of Minnesota, at Eureka Town Hall on the 14<sup>th</sup> day of March, 1972 was called to order by the clerk, Hilman Leine and Henry Wall was then chosen to preside as moderator at the meeting.

The moderator, at the opening of the meeting, stated the business to be transacted and the order of same, as follows: To elect one Supervisor for the term of three years, to fill the place of Martin Mohn whose term expires. One supervisor for 1 yr. term to fill the unexpired term of WM Curry (deceased)

It was then, on motion, Resolved, that the compensation of the Town officers elected at this meeting shall be \$10.00 per meeting for a supervisor. \$400.00 annual for Clerk.

On motion, it was ordered, that the following sums of money be raised by tax upon the taxable property in said town for the purposes of current year: For General Revenue \$15,000.00.

On motion, it was ordered that the following additional sum of money be raised upon the taxable property in said town pursuant to Laws 1937, Chapter 379. For general township purposes \$15,000.00. On motion, it was Resolved not to accept the Dakota- Hue sanitary land fill proposal.

On motion, it was resolved that Lakeville Fire Department serve all of Eureka. Amended to allow town board to negotiate more equitable terms with Farmington also boundaries of territories to be served by each.

On motion, it was Resolved to allow town board to select a planning commission.

On a motion, it was Resolved to raise pay of supervisors to \$10.00 per meeting. Clerks salary set at \$400.00 per year.

On motion, gopher bounty to be paid by town.

On motion, it was resolved that the board present and enact an ordinance controlling shooting and hunting in Eureka in line with neighboring townships.

The next Annual Town Meeting to be held at 2<sup>nd</sup> Tuesday in March at town hall.

At 8:00 the polls were closed, proclamation thereof being made by the moderator. The Judges then proceeded to publicly canvass the votes, and persons having the greatest number of votes for the respective of fices voted for were declared elected.

STATEMENT OF RESULT OF CANVAS- to be Read Publicly by the Clerk.

The following is a statement of the result of the board of canvas of votes for the election of officers, and for the various propositions submitted at the Annual Town Meeting in the Town of Eureka County of Dakota and State of Minnesota, March 14, 1972 as publicly canvassed by the Judges at said meeting.

Henry Larson received 116 votes for Supervisor, term 3 years. Robert Johnson received 66 vote for Supervisor, term of 3 years.

Henry Larson was declared elected Supervisor for the term of 3 years to fill Martin Mohn whose term expires.

Hilman Leine received 171 votes for Town Clerk.

Mrs. Garrick Mallery received 165 votes for Treasurer. Charles Dunn received 1 vote for Treasurer

J. Hinkle Mallery received 119 votes for 1 year supervisor. Gerald Swedin received 62 votes for 1 year supervisor.

J, Hinkle Mallery was declared elected.

Larry Mallery received 19 votes for Constable.
