

EUREKA TOWNSHIP MEETING SEPTEMBER 11, 1989

MEETING CALLED TO ORDER AT 7:30 P.M. BY CHAIRPERSON LEE. PRESENT WERE SUPERVISORS CURRY, KADLEC AND SCHINDLEDECKER, CLERK LEINE AND TREASURE SCHULZ.

CLERK LEINE READ THE MINUTES OF THE AUGUST 14, 1989. SCHINDLEDECKER MOVED TO ACCEPT MINUTES AS READ SECONDED BY KADLEC AND CARRIED.

CURRY MOVED TO ACCEPT TREASURES REPORT AS READ SECONDED BY SCHINDLEDECKER AND CARRIED.

CLERK LEINE INTRODUCED BILLS TOTALING \$17,018.62. INCLUDED IN THESE BILLS WERE \$6,742.00 FOR FIRE PROTECTON FROM THE CITY OF LAKEVILLE FOR 1989, AND \$4,202.64 TO VIKING STEEL FOR CULVERTS. KADLEC MOVED TO PAY ONLY \$1,990.20 OF THE VIKING BILL, BECAUSE PART OF THIS ORDER WAS DEFECTIVE. THIS MOTION WAS SECONDED BY CURRY AND CARRIED. SCHINDLEDECKER MOVED TO PAY BILLS AS AMENDED, SECONDED BY CURRY AND CARRIED.

JIM PEPERA, 9180 235TH ST, LAKEVILLE REQUESTED RENEWAL OF HIS CUP. CURRY MOVED TO RENEW PERMIT, SECONDED BY KADLEC AND CARRIED. FEE SET AT \$10.00.

THE QUESTION OF FIRE PROTECTION TO AIRLAKE AIRPORT WAS AGAIN BROUGHT BEFORE THE TOWN BOARD. THE POSITION OF THE BOARD HAS NOT CHANGED. QUOTED FROM THE MINUTES OF THE NOVEMBER 14, 1988 TWP MEETING. "BOARD MEMBERS MEET WITH BERRY CHRISTENSON, LAKEVILLE FIRE DEPT. AND JIM MICHELL, FIRE MARSHALL, ON OCT. 17. THE SUBJECT WAS WATER TO AIRLAKE. TWP WAS ADVISED IF MAC WANTS TO PURCHASE WATER FROM THE CITY OF LAKEVILLE ON A PRIVATE AGREEMENT, THE TWP SHOULD LET THEM DO SO. LAKEVILLE FIRE DEPT. SUGGESTED THAT MAC SHOULD SUPPLY AND MAINTAIN ANY SYSTEM INSTALLED."

NEIGHBORS NEXT TO THE HARVEY HANSON PROPERTY, LOCATED AT 6220 235TH ST, HAVE COMPLAINED TO THE TWP ABOUT THE UNSIGHTLY APPEARANCE. CHAIRPERSON LEE TO CONTACT MS. SNOWELL RALEIGH, 3074 LUVERNE CT, LAKE ELMO, INFORMING HER OF NEIGHBORS CONCERNS.

MAC HAD A MEETING IN AUGUST TO LAY THE GROUND WORK FOR FUTURE MEETINGS AND ELECTION OF OFFICERS. NO CAPITAL IMPROVEMENT IS SLATED FOR 1989. MORE HANGERS WILL MOST LIKELY BE THE NEXT STEP IN THE EXPANSION OF AIRLAKE. NEXT MEETING WILL BE NOVEMBER 2ND.

KADLEC MOVED TO REPLACE DEFECTIVE CULVERTS WITH NEW ONES AND RETURN DEFECTIVE ONES TO VIKING STEEL. CURRY SECONDED THIS MOTION AND MOTION CARRIED.

CURRY MOVED TO ADJOURN AT 9:00 P.M., SECONDED BY SCHINDLEDECKER AND CARRIED.
