Sending parcel divided in 1981stub abstract provided. Receiving parcel currently is an active mining. Wetland determination was submitted. Attorney Lemmon's stated as long as current setbacks are met, a single-family house could be permitted. Chair Sauber moved to recommend approval to the Town Board of a Building Right Transfer from Progressive Resources LLC 13-00500-01-013 to Fridges Landscaping, Inc. 13-007-26-030 With the condition that when the right is to be used that current mining setbacks must be met and wetland set backs are met.
