Planning Commission Research Conducted 2023-2024

- Mines: Ordinance review and revision continued, with a public hearing and ongoing communication with the mines. Recommendations made to the Town Board. Attendance at 2 Dakota County Model Mining Ordinance Workshops.
- Housing Rights / Subdivision Ordinance Review and Recommendations: Public Hearings held, and ordinance revisions implemented by Town Board.
- Township Road Improvements: Monitoring of local road conditions, and research into improved methods of gravel road maintenance to improve road surfaces and reduce costs. Staff attendance at U of MN Local Technical Assistance Program (LTAP) "Gravel Road Maintenance and Design" provided valuable information.
- Township Road Safety/Speed: Legal research into State regulatory laws concerning road speed. Ongoing technical research and documentation is required to identify qualifying residential township roads for posting of lowered speed limits. Results include improved road safety and lower maintenance costs.
- Broadband Expansion: Township citizen survey conducted. State funding used for implementation and expansion of High-Speed Internet availability in specific areas of Township.
- Night to Unite: Eureka's 1st ever Public Safety community event organized and implemented by Township staff and sponsored by area businesses and donations. Food, games, prizes, along with emergency personnel, vehicles and demonstrations made it a very successful event.
- 2040 Comprehensive Plan: Ongoing compliance with plan.

Motion to approve the 2023 Treasurer's Report

Bill Clancy moved to approve the Treasurer's Report. Lu Barfknecht seconded the motion. Motion carried unanimously.

2023 Financial Highlights

 - Estimating a 40% increase for 2025 to \$72,555

Clerk Atwater explained that the Township was still in negotiations with Farmington Fire Department regarding the contract and the fees. Even though there is not a contract in place at this time, Farmington is still covering any fire calls while negotiations are going on.

2025 Proposed Levy and Budget

Clerk Atwater reported that the Statewide Township average levy increased by 6.8% in 2024, and that Eureka Township did not have an increase.

Motion: Pete Storlie moved to approve the 2025 Levy in the amount of \$764,329. Mark Ceminsky seconded the motion.

Kathleen Kauffman stated that gravel quotes are not in or selected which are a big part of the budget. There will also be a change in government, which can impact where funds are allocated. She thinks that there would be a lot more certain in July than we have right now. The new Board will be in place, they will be organized, and they will begin to take steps on what to do with the roads and the fire contracts. Even if I think the levy seems reasonable on it's face, but there are too many unknowns that I don't want to agree to the levy now, I would vote against it.

Beth Eilers questioned if we approve this levy, and our bills come in higher and we are short significantly, what would happen?

Carrie Jennings reply that the Township would need to cash in the CD's.

Clerk Atwater stated that the Township would have to use its reserved funds. She continued that if the Township would do this year after year, the Township would come to a point where they no longer have those reserves and loans would need to be taken out.

Lee Slavicek wants to vote on the levy tonight and not kick the can down the road. He stated he wants to take care of it tonight. The nice thing about Eureka is we come, we set our budget, and we live by our budget.

Pete Storlie added that the levy should be set tonight based on his motion. He pointed out that it is hard to get people to come back to the building and this is one of the best times to get people here.

Carrie Jennings asked Pete Storlie, how he came up with the number?

Pete Storlie replied it is the same as last year. Zero percent interest.

Chuck Kaufmann asked why in an era at 3-5% inflation, the budget would stay the same?

Pete Storlie replied that everyone has taken hits financially. The Township has money, and it needs to be managed and good things, and there is more that can be done. The new

Board should have the opportunity to manage it. These citizens keep having to pay more money. We have to be smart how we manage our money.

Ken Olstad stated he wanted to speak against the motion. He thinks we should go with what was recommended by our governing people, because they know their stuff and we elected them.

Bill Clancy commented he was trying to figure out the downside of kicking the can down the road and he appreciated Pete Storlie's comment about getting people back into the building. He doesn't know how many years it's reasonable to not expect to spend more than we are spending. We are already short of money.

Lu Barfknecht piggybacked on Bill Clancy and Ken Olstad's point that we are short money. She stated she is against the motion, due to the fact that last year the citizen stated they wanted more money to put towards the roads. You can't put more money on the road without more money. If we don't increase the levy, you will take funds from other places in the budget.

Beth Eilers recommended maybe meeting in the middle at 3% increase so that we don't tap into our funds. Yes, we need to be fiscally conservative, but we need to also be cautious.

Nancy Sauber pointed out that the increase 5.37% which is still significantly less than what the average was last year statewide. Costs are going up and nobody likes it. If we can fund what we need to do, then people are going to have suffer cutbacks.

Mark Ceminsky stated we need to be financially responsible to our citizens. There are areas in our budget that we are overspending. He believes there is money in the current budget to absorb some of these fees.

Gary Gunderson called for a vote or a question. Mark Ceminsky seconded.

Carrie Jennings asked all who want to end discussion now, vote now. The vote was unanimous to end the discussion.

Carrie Jennings asked for a vote for the motion on the floor which is a zero % increase, keeping the levy at \$764,329. Ayes- 14, Nays- 16, Motion Failed.

Motion: Lee Slavicek moved to go with the recommended amount of \$805,347 for the 2025 levy. Ken Olstad seconded the motion.

Kathleen Kaufmann called the question. Lu Barfknecht seconded. The vote was unanimous to end the discussion.

Carrie Jennings asked for a vote for the motion on the floor which is to accept the levy proposal at \$805,347. Ayes- 16, Nays -13. Motion Carried.

Motion: Mark Ceminsky moved to set the 2025 Annual Meeting for March 11, 2025, at 8:15pm at the Eureka Town Hall. Lee Slavicek seconded the motion. Motion carried unanimously.

Carrie Jennings announced that the Polling Place for Eureka Township Elections 2025, will be March 11, 2025, from 7:00 am to 8:00 pm at the Eureka Town Hall.

Motion: Beth Eilers moved for the Town Board request that a traffic counter be conducted on 257th from the Town Hall to Highview to get a baseline of traffic at this time. Bill Clancy seconded the motion. Motion carried unanimously.

Mark Pflaum stated the roads are much better. He has noticed the mailperson is having issues with mailboxes when departing and asked for spot gravel in those areas.

Kathleen Kaufman commented that at the last Town's meeting people were rightly upset with weather and combined with bad road maintenance in prior years. She thinks Mark Henry has been working on the problem and he has done a great job.

Colleen Riley wanted to public say thank you to Liz and Amy. She stated they are doing a fantastic job.

Clerk Atwater announced the election results.




