**Experience:** Contractor has performed road maintenance services that are the same or similar to the services being requested by the Town to the local government entities listed in Attachment 2 of this bid.

Contractor will be compensated by the Town based upon the number of **actual** hours spent providing road maintenance services at the hourly rates set forth above. I understand the Town is not guaranteeing that there will be any minimum number of hours of work provided under the contract.

I also understand the agreement under which the services will be provided is not an exclusive agreement.

In submitting this Bid, it is understood and agreed that the Town reserves the right, in its sole discretion, to reject any and all bids, accept any bid, waive informalities in bids submitted and waive minor discrepancies between a bid and the related documents as it deems to be in its best interests. Any waiver of the Town with respect to the requirements of the Bid Form and related documents shall apply only to the particular instance for which it was made or given and no such waiver shall constitute a permanent or future waiver of such requirements.

I hereby certify that the above Bid constitutes a valid and binding bid to provide road maintenance to Eureka Township pursuant to the terms of the attached Agreement and all exhibits. I further understand and agree that my Bid may not be modified once submitted. I also agree that I have provided to the Town proof of insurance and if awarded the contract, I will add the Town as an additional insured under said policies.

I represent that I have carefully examined the bidding documents, including the agreement, and have become fully informed of existing conditions and limitations under which the work is to be performed. Submittal of a Bid shall be conclusive evidence that I have made such an examination. I understand that failure to make such an examination shall not be accepted as a basis for claims for extra compensation.

I represent that my Bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm, organization or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation. I represent that I have not directly or indirectly induced or solicited any other contractor to submit a false or sham bid. I represent that I have not solicited or induced any person, firm or organization or corporation to refrain from bidding, and that I have not sought by collusion to obtain for myself any advantage over any other contractor or over the Town.
